Pastor's Page

Dear Sisters and Brothers in Christ,

Nearing the end of a week's vacation, I am sharing these words with you. It has been a good week, good to share more time with Anne. Two new friends came into our lives. I've been doing things around the house. The Adirondack chairs on the front porch and the patio received some use. I prayed for each of you by name. I heard from some of you and others of the community who had an urgent need. It's been my second week of vacation since the beginning of October. I am grateful to have had this time.

I've also received phone calls from other Pastors, wondering how my vacation was going. And I have done some listening. The clergy friends who called me, to whom I listened, expressed concern for the health of congregations of believers in Jesus Christ. One of them is a chaplain with a unique perspective as his congregation he serves is a senior care facility, whose residents are ever present. Yet, as a member of another congregation, he sees what many clergy see. Attendance is half, or even less, than what it was before the pandemic. He expressed his concern for the congregations and the larger Church, the people of God. The loss of community is evident in the local congregation in which he and his wife are fed. Another Pastor, checking in on me while I was on vacation, expressed concern for the congregations of our Green Bay Conference. The Conference includes congregation from Pulaski to the Lake, and from Washington Island to Keil. The Pastor focused on the congregations of Green Bay. She mentioned some are not financially viable. One is being served by a member who is a retired 91-year-old Pastor. He is filling in. One recently called a new Pastor, as the former Pastor was told that if she didn't lead worship in the sanctuary through the entire pandemic she should leave. In a number of congregations, the pastors are planning to retire early because they can. Another congregation will be served by an intern for two years. After the conversation, I prayed. There is good news, it is the Good News, Jesus Christ! The Church is the Church because of the saving activity of Jesus! This has not changed.

We have changed. We are not worshipping as often, we are finding other things to do, we are not offering our gifts as we were prior to the pandemic, we are giving our time and money to other things. The community has changed because of our choices. For one week, I have been away and what I have missed most has been being in community with you all for worship of the Lord. The Church will always be the Church. God makes it so. Communities of faith are changing, that change is on the individuals of those communities.

If you have been away from the community of St. Paul Lutheran Church, know you have been missed. For those of us who have been present in community, we know the joy of worshiping together, serving together, hearing the Word together, singing praises to God together, and being fed together. We are members of the Body of Christ, that's God's doing! What do we wish for the community of faith known as St. Paul Lutheran Church in Juddville? What will we as a congregation look like, to be for the world? How will we serve the world? God is stirring the Spirit in and through this community. The question is, do you want to be a part of this community, do you want to be stirred?

Enjoy these summer days, and I pray we worship and meet in community, Pastor Frank Kauzlarich





Financial Update



- FYTD = Fiscal Year-to-Date. St. Paul Lutheran's fiscal year begins on 01-Oct.
- The 2021-22 fiscal year Ministry Expenses budget is \$250,954
- Regular Offerings in the nine months of the current fiscal year were greater than budgeted by \$2,985 (\$183,345 - \$180,360) but \$2,281 lower than received in the comparable prior year period
- Ministry Expenses were higher year-over-year by \$15,171, principally reflecting higher Benevolence expenses which benefit others and increased heating costs (\$11,728 and \$2,442 higher, respectively)



- FYTD = Fiscal Year-to-Date. St. Paul Lutheran's fiscal year begins on 01-Oct.
- June's General Offerings (\$12,134) were the second lowest of this fiscal year
- General Offerings in the first nine months of the 2021-22 fiscal year varied substantially (from a low of \$11,959 in November to a high of \$35,939 in December)
- Monthly Ministry Expenses were less variable, ranging from \$17,927 to \$31,019
- The higher Ministry Expenses recorded in December, February and March reflected strong support for, and timing of, Benevolence disbursements (e.g., Ukraine Relief)

Council Highlights

JULY COUNCIL MEETING HIGHLIGHTS

Following are the highlights of the July 20th Church Council meeting.

- Bob presented devotions based on Matthew 6: 19 24.
- Two urgent need requests have been approved during July by the Executive Committee.
- Nominations are being sought for council membership for presentation at the annual congregation meeting. Per the constitution, a nominating committee needs to be appointed at the annual meeting for 2023.
- Council approved the local benevolence ministry recommendation for contributions to Neighbor to Neighbor (\$750), Habitat for Humanity (\$250) and Family Service of NE WI (\$500). Karen added that the "No Child Wet Behind" Diaper Drive will be returning to St. Paul in August.
- Greg summarized the initial draft of the 2022-23 spending plan based on the counsel's recommendation that the budget reflects achievement of ministry goals.
- Benevolence giving has been "amazing" with financial donations going to ELCA Tornado Disaster Relief, ELCA Colorado Fire Disaster Relief, Lutheran World Relief Urkraine War Humanitarian Relief, East Central Synod of WI, plus eight local benevolence ministry organizations so far this year.
- Council approved an increase in pastor's mileage reimbursement/allowance, consistent with the IRS mid-year rate adjustment.
- There was concurrence that a letter be sent to members encouraging regular worship attendance and strong financial support.
- Pastor shared that the Stadtmuellers have volunteered to host outdoor coffee between worship services.

Remember that the detailed and council-approved minutes of the July meeting will be published in the September Epistle. In the meantime, feel free to contact any member of council with questions or comments.

Council Meeting Minutes

Wednesday, June 22, 2022

Mission: St. Paul Lutheran Church is a welcoming family bringing Christ into people's lives by developing, nurturing and supporting disciples.

Meeting Call to Order

The meeting was called to order by Betty Eisenhauer at 6:30 P.M.

Devotions

Jeff read a devotion regarding Psalm 27 and discussed its meaning.

Agenda Approval

Betty made a motion to approve the agenda and it was approved by acclamation.

<u>Minutes</u>

The previously circulated minutes from the May 18, 2022 meeting, following a motion made by Karen and seconded by Cathy, all aye, were approved.

Record of Electronic Business Approval

The proposal from the Communications Ministry for the Instant Church Directory Administrative Software service to communicate with members approved at the May meeting was discussed again with no objections.

REPORTS AND MINISTRY ACTION ITEMS

Pastor's Report

Pastor Frank discussed plans for the cruise on the Nor Dorr out of Sister Bay Marina. The members of the Ephraim Moravian Church were also invited. He had been working to make sure the sound system, music, seating for the picnic were all arranged. Pastor Frank mentioned that he was planning to take vacation from June 28th through July 4th. He indicated that the Synod's Bishop heard from the churches and there was now agreement on funds being forwarded to the Synod. **Financial Report**

Financial Report

May 2022 Financial Summary

Greg provided an abbreviated Financial Summary for May given his prior mailing of the financial information to the Council earlier in the week and the need to commence initial planning for the 2022-23 budget relating to fourteen finance-related matters.

Total Offerings in May, the eighth month of the 2021-22 fiscal year, were \$28,400, approximately \$11,900 higher than in the same prior year month. May Offerings included \$670 designated for Ukraine Relief, \$75 for Global Benevolences, \$245 for Urgent Need and a \$100 Memorial donation. Regular Offerings (i.e., Total Offerings less Urgent Need and Memorial donations) of \$28,100 were

approximately \$8,000 higher than budgeted. Ministry Expenses in May were \$16,900, approximately \$2,000 less than the budgeted amount and \$700 higher than in May 2021. The \$670 of Offerings designated for Ukraine Relief will be sent to Lutheran World Relief in June. May's Net Ordinary Income of \$11,200 was approximately \$11,000 higher than the gain recorded in the same prior year month.

Undesignated cash in the Nicolet Bank checking account was \$53,100 as of May month-end, consistent with our intention to maintain at least two months coverage of Ministry Expenses in the main checking account as of month-end.

Fiscal Year-to-Date Financial Summary

Regular Offerings (i.e., excluding Urgent Need and Memorial donations) for the current fiscal yearto-date period totaled \$171,200, or approximately \$300 higher than the prior fiscal year- to-date period. On a constant monthly budgeted basis of \$20,040 per month, fiscal year-to-date Regular Offerings were \$10,900 higher than budgeted.

Total Ministry Expenses (i.e., excluding Dedicated Funds and Endowment-related expenses) totaled \$171,100, which was \$18,700 higher than the comparable prior eight-month period. Total Benevolence and Heating Expenses were \$14,500 and \$2,400 higher, respectively, while Insurance Expense was \$900 higher given a full year payment of the premium in October and Professional Services were \$300 higher. The fiscal year-to-date Ordinary Net Income (excluding Dedicated Funds and Endowment-related activity) was approximately \$600. The current year's eight-month Ordinary Net Income was approximately \$18,200 lower than the \$18,800 Net Ordinary Income amount recorded in the comparable prior fiscal year period.

Online Giving Update

Online giving contributions in May 2022 totaled approximately \$6,200. To date, thirty-three member households made at least one contribution through the site in the first eight months of this fiscal year. Approximately \$62,000 has been received through online giving in the first eight months of the 2021-22 fiscal year (i.e., approximately 36% of fiscal year-to-date Offerings). Approximately \$59,600 was received through online giving in the 2020-21 fiscal year. (which represented approximately 25% of Offerings received).

ELCA Endowment Fund Developments

The ELCA Endowment funds return for the first four months of 2022 was a (9.89%) loss versus a 2021 calendar year gain of 12.14%. This included a (5.05%) loss in April, a period experiencing a significant market downturn.

Liquidity Considerations

Excluding Memorial, Endowment or designated funds, approximately \$133,400 of funds were available as sources of liquidity as of 31-May-22. This includes the impact of the \$28,000 Small Business Administration ("SBA") PPP loan forgiven by the SBA in April 2021, the \$10,700 Employee Retention Tax Credit ("ERTC") payment for 2Q'21 received from the Internal Revenue Service in September 2021 and the 3Q'21 \$9,600 ERTC payment received in February 2022. Exclusive of designated funds for Memorial, Urgent Need or the Cemetery, available liquidity would cover six months of Ministry Expenses.

Other Financial Developments – Information Update

The annual budget process for the 2022-23 fiscal year is now underway. The Treasurer and Financial Secretary sought the Council's conceptual guidance on several budget-related matters at this meeting. The Treasurer plans to prepare a first draft of a 2022-23 budget for the Council's discussion and review at the July Council meeting. The Treasurer's review of current Financial Processes documentation with the Church Council is ongoing at each Council meeting. This month's update, which provides an overview of the annual budget process, will be distributed for additional discussion at the upcoming Council meeting. The Financial Secretary has developed an abbreviated summary Income Statement format, which may prove useful for future congregational updates. The Treasurer would like to receive the Council's feedback as to whether it would be useful to provide such a summary quarterly to the congregation.

Budget Planning – Greg

Greg led the discussion regarding the major items that need to be addressed in the next budget.

- a. Salary Adjustment: Greg noted the current rate of annual inflation rate has risen to 8.6% which needs to be considered vis-à-vis the East Central Synod of Wisconsin's ("ECSW") 2023 Compensation Guidelines when reviewing proposed salary increases for ministers. The Church must compensate Pastor Frank at least the minimum level as established by the 2023 ECSW Compensation Guidelines.
- b. Giving Trend for FY22-23: It appears that as of 31-May-22 total giving is essentially flat to last year. This needs to be carefully considered by the Council when projecting next year's budgeted Offerings and the recommended level of budgeted Ministry Expenses.
- c. Music Director Position: The Council agreed that there are too many uncertainties to budget for a music director for next year, including the resumption of full Choir participation at each indoor worship service.
- d. Endowment Committee Membership & Drawdowns: The expectation is that we will earn approximately \$8,000 of current year Income Distributions this and each subsequent year from the Everlasting Gift Endowment Fund which compares to \$12,000 of planned withdrawals this fiscal year. The Council should consider potential future portfolio returns when considering proposed 2022-23 withdrawals from the Everlasting Gift Endowment Fund. The Endowment Fund Committee's three-person terms in office need to be reviewed by the Council to ensure the members' terms are staggered over three years.
- e. Expected Propane Costs: The per gallon price will be significantly higher than last year and the Church will need to shop around for the best deal.
- f. Musician Back-up Plans: We will still need a backup if Doreen is unable to play.
- g. Pastor's Mileage Reimbursement: In June, the IRS increased the standard mileage rate for business travel reimbursement to \$0.625 from \$0.585 per mile (up 4 cents) effective July 1st. This was the first mid-year increase since 2011 and was up from \$0.56 per mile in 2021. Pastor's annual reimbursement amount needs to be increased to at least \$6,000 from \$5,500 at this time to properly account for this recent change in IRS reimbursement and should be further reviewed for the appropriate amount for 2022-23.
- h. Expected Maintenance/Property Projects: Painting the fellowship hall and having the cemetery surveyed should be considered.

- i. Financial Secy. Contingency Back-Up Plan: If Shawn is unable to perform her duties the Church will need to find a backup. Greg estimated that cost in the range of \$50 per hour for an extensive amount of hours.
- j. Liquidity Target Balances: There is approximately \$130,000 in cash which meets the six-month goal and the checking balance has at least \$40,000 which would cover two months of Ministry Expenses.
- k. Song Leader, Worship Leader, Office Support Needs: Mary is currently working the maximum hours now which is 20 hour per week. The custodian position needs review. The need for a song leader during the winter months is open for discussion.
- I. Capital Projects: Painting the fellowship hall, getting a survey of the cemetery and making sure all the door locks are working as expected were highlighted.
- m. Technology Plans: It does not appear that the StarLink dish is coming any time soon. Now we are scheduled for delivery in 2023. The addition of a two-drive network area storage device (NAS) would provide better network access for Pastor Frank and Shawn as needed.
- n. Benevolence Plans: During the discussion of this issue the idea of incorporating the church was suggested. The concept will be discussed with the Church's lawyer.

3rd Quarter Local Benevolence Recipients

Karen indicated that the committee will be considering allocations of \$4,000 and that \$6,800 is available for Urgent Need.

Old Business

Property & Maintenance Update – Peder discussed cemetery survey costs and noted that Steve Stringer and Tom Prohl have been helping a great deal with Property & Maintenance topics.

Global Benevolence Fund Distribution – Pastor Frank indicated that three volunteers are now available to meet regarding potential global benevolence fund recipients.
