COUNCIL HIGHLIGHTS - December 13, 2023

Council began with a devotion based on facing death with faith. The topic sounds grim until we remember our sure hope of the resurrection, a hope that brightens the picture, always.

Since the last meeting, Council electronically approved the purchase of a white parament for the altar, a topic discussed for years. We're looking forward to seeing the parament in use.

Council celebrated all that went on the weekend of December 9th/10. Members came together to decorate the church, address cards and gifts for those in need, and almost 60 stayed after worship on the 10th for a potluck to better get to know each other. None of this was possible without many hands and hearts sharing their gifts. Pastor proposed another potluck on February 3rd. Plans and details to follow.

Council considered two applications for the St. Paul scholarships and decided to go with grace and award \$1000 to both of the St. Paul college students who applied. Members discussed the possibility of moving that scholarship to support a seminary student in the future.

Council celebrated that our new Administrative Assistant, Megan Williamson, is getting rave reviews from those who have come into her circle, both those training her and those working alongside her. We have prayed that God would send just the right person, and though His answer was delayed for 8 months, as usual, all things work together for good. We are grateful.

Council heard that the new membership directory will come to members early in 2024. Those who have not submitted a photo are encouraged to do so. It helps greatly to be able to put a face to a name.

Council expressed thanks for all our staff, Pastor, office, custodian and musicians, who work diligently all year, but especially during the seasons of Advent, Christmas, Lent, Holy Week and Easter. Staff will receive a Christmas gift from the congregation as a token of our thanks.

Council will consider a bid for a new copier lease, as our current lease has expired and the copier we now have has become outdated. Newer models have capabilities and security features that our current model lacks.

Council members spoke to our desire to have our Synod Bishop visit St. Paul as a way to strengthen our relationship with Synod staff and the resources available there.

The next Council meeting will be on Wednesday, January 17, 1:00pm. Complete, approved minutes of the December Council meeting will be published in the February Epistle.

Council closed as always with prayers for those in need and prayers of gratitude for each of you and your ministry among us.

Merry Christmas, from Door County.





Fiscal Year-to-Date Financial Summary

- Regular Offerings (i.e., excluding Urgent Need and Memorial donations) in the first two months of the current fiscal year period (Oct'23 – Nov'23) totaled \$28,800, or approximately \$3,500 lower than last year
 - On a constant monthly budgeted basis of \$21,400 per month, 2022-23 fiscal year Regular
 Offerings were \$14,000 lower than budgeted
- ➤ Total Ministry Expenses (i.e., excluding Dedicated Funds and Endowment-related expenses) totaled \$43,800, which was about \$300 lower than the prior fiscal year
 - Benevolence Expenses of \$2,100 were \$900 higher than in the prior fiscal year
 - Insurance and Communications costs were \$500 and \$300 higher, respectively, while Total
 Staff Ministry Expenses were \$1,800 lower
- ➤ The fiscal year Ordinary Net Loss (excluding Dedicated Funds and Endowment-related activity) was approximately \$14,800
 - The 2023-24 current year-to-date Ordinary Net Loss was approximately \$3,100 worse than the \$11,700 Ordinary Net Loss recorded last year
- Note: All amounts rounded to the nearest \$100.







COUNCIL MINUTES – October 18, 2023

Mission: St. Paul Lutheran Church is a welcoming family bringing Christ into people's lives by developing, nurturing and supporting disciples.

Council Members Present: Pastor Frank, Greg Ehlke, Steve Stringer, Jeff Kuckenbecker, Renee Schwaller, Cathy Mestek, Betty Eisenhauer, attending as guest **Excused**: Karen Peterson, Peder Nelson, Pam Davis

Meeting Call to Order: The meeting was called to order by Cathy Mestek at 5:47pm.

Devotion: Pastor led devotions centered on the importance of "showing up" in all ways for those around us in need.

Agenda Approval: The previously circulated agenda was approved by all.

Administrative Assistant Position - The first order of business was a presentation by Betty Eisenhauer concerning an applicant for the Administration Assistant position, vacant since March 31. Betty has deep experience in personnel and human resources and has been assisting Council in the hiring process. Betty outlined terms of employment for the Council to consider and also shared her thoughts regarding the candidate based on the interview and written professional recommendations. After discussion and fine-tuning of the terms, Betty recommended that we extend an offer to this candidate, with employment to begin on December 4th and a 6-month orientation/probationary period. Jeff moved that Council authorize Betty to offer this candidate the position with the terms of employment outlined; Steve second. Motion was unanimously approved. Council thanked Betty for sharing her many gifts, these included, with St. Paul.

Approval of October Minutes - Minutes of the October 18 Council meeting, previously distributed, were unanimously approved, after Steve so moved; Renee second.

Council Reorganization - The next order of business was for Council to reorganize for the coming year. Following are Council offices and ministry liaisons:

Community of Faith - Council members shared various thoughts. Of note, was that "The Chosen" study group has completed this season and will resume their study in the spring, with all welcome to join. Council thanked Jeff and others who have led this group, bringing those involved into a close-knit community.

Treasurer's Report - Greg Ehlke, Treasurer, presented his financial report, as summarized below. Council received complete documentation to support the findings.

Following are the key takeaways from the Financial Summary for October:

- (i) Financially speaking, October was a relatively weak month as Total Offerings were about \$13.0K, which was about \$2.5K lower than the prior year month and \$9.7K lower than budget;
- (ii) October's Total Ministry Expenses were \$21.4K or \$1.4K lower than in October 2022 we paid the full year's premium for our liability insurance and Workman's Compensation insurance policies from Church Mutual (total cost of \$5.3K) and there were no Benevolence outlays;
- (iii) We had about \$66.2K of undesignated available liquidity in Nicolet Bank accounts plus petty cash and about \$52.2K of brokerage account assets (virtually all UST bills and notes) together this liquidity would cover about 5.5 months of Ministry Expenses without receiving any additional Offerings our liquidity position was a little weaker than in October 2022.

Steve moved to accept Greg's report, Pastor Frank, second, unanimously approved.

Pastor's Report - Pastor Frank has been working ahead to prepare for Thanksgiving, Christ the King, Advent and Christmas worship. The Advent worship theme will be based on, "O Come, O Come, Emmanuel." Pastor has also been diligent in his visitation of the homebound and those in need. He shared the good news that another couple has asked to join St. Paul. Pastor moved, Jeff second to accept and welcome Dennis and Connie Stiegenberger as members. Motion was unanimously approved. Dennis and Connie will be publicly received during an upcoming worship service.

Property - Steve reported that the cemetery survey has been delayed, but is to be completed in the coming months. Chris Kuhnz, custodian, will be painting the kitchen in the new year. A group of volunteers worked outdoors to prepare the grounds for the winter season. Yet another group will be gathering on Friday to put up the outdoor Christmas lights. We are grateful.

Worship & Music Ministry - Jeff reported that the ministry met and welcomed the energy a new St. Paul member brought to the team. He noted that the music ministry at St. Paul has come out of covid as a strong part of worship once again. Many worshippers have commented as to how grateful they are to have a choir, praise team and special music as a part of worship. December worship services will continue at 8am and 9:30am, indoors and out, with the exception of Christmas Eve and Day. On Sunday, December 24, worship will be held at 9:00am, 5:30pm and 7:30pm, indoors and parking lot. On Monday, December 25, worship will be offered as a single 9:00am service, indoors and parking lot.

Local Benevolence - The ministry has requested approval of a \$1,500 gift to the Boys and Girls Club of Door County to purchase gifts for those in need. This amount would cover gifts for 15 children. Steve so moved, Greg seconded. After discussion, the motion was unanimously approved.

Volunteer Recruitment Follow-up - Bev Prohl has compiled and provided to Council members and other ministry leaders a list of those who would like to volunteer at St. Paul in various areas. We discussed the importance of following up with those who have offered to share their gifts. Cathy will be in charge of updating the list and sharing updates as

members ask to be added to the list. We are very grateful for all those who have already added their names in many ministry areas.

Sanctuary Lighting - Council had previously discussed the possibility of upgrading the sanctuary lighting and perhaps changing out some of the fixtures. Karen and Steve had both looked at options. However, Council has heard widely differing opinions from St. Paul members regarding the lighting and fixtures. (As Karen aptly pointed out, "There is less consensus than there was in picking a Speaker of the House.) Council agreed the new light bulbs have made a big difference and these coming months with evening services will give us a better handle on how the lighting affects worshippers. We are in agreement to go no further with this project at this time.

Church Directory - Volunteers in the office have been diligently working to ensure we have one accurate membership directory, not an easy task. Members have been asked to either submit a directory photo or to have their picture taken on a Sunday morning by our own Steve Stringer, who is only joking (we think) when he offers 8 x 10 glossies for sale. The goal is to have a directory to distribute in print and online to members in the very near future, so that we can at last put a face to a name.

Streaming Proposal Update - Funds were approved at the Annual Meeting for equipment to allow us to live stream worship services. Council agreed that December is not a good time to undertake the effort to install equipment and provide necessary training to those using it. The streaming proposal will be revisited in January.

2023 Scholarship Applications - Council has received 2 applications for the \$500 scholarship given to college students who are part of the St. Paul congregation. Council members are conflicted about the matter. At issue is that the first line of the qualifications states that a recipient is to be an, "Active member of St. Paul Lutheran Church in Juddville (active is defined as attending worship and receiving Holy Communion)." Council members expressed some doubts that applicants may qualify on this point, though we also discussed whether a measure of grace could apply. We agreed that at a minimum it would be good if we had a chance to meet the recipients at a worship service and to offer them our best wishes and prayers. As the night was getting long, and we didn't have the two completed applications in front of us, Pastor suggested that he email Council members the completed forms so that we can vote electronically.

Adjournment - There being no other business, nor the energy to pursue it, the meeting adjourned at 8:10pm. The meeting concluded, as always, with the Lord's Prayer, because no matter how tired we are, there is always room in our lives for prayer.

Next Council Meeting: The next meeting will be on Wednesday, December 13, 1pm at St. Paul; Cathy Mestek doing devotions.
